All contract players must be members of All Seasons Tennis Club (“ASTC”). While ASTC discourages changes to the day and time of contracts throughout the contract season, it will make efforts to accommodate changes dependent on available court time. ASTC will permit make-ups if the club is closed due to inclement weather. All such make-ups must be used by the end of the above contract period.

A deposit is required to reserve the court time for the contract period. If ASTC is unable to fulfill the contract requested, ASTC will make reasonable efforts to provide alternative contract time requested by the captain but this cannot be guaranteed. If this situation arises, the deposit WILL be refunded, and this is the ONLY situation in which the deposit shall be refunded. **Both the deposit and balance due must be paid in its’ entirety by either the captain or a team member.** Deposits are due by May 15, 2011 and the balance is due in FULL by September 30, 2011 to ensure these rates. Non payment by these dates will result in an increase to the cost of this contract. If an application is submitted after May 15, 2011, the deposit must accompany the application; the balance due will be according to the standard payment terms.

All applications are subject to approval of ASTC. Management reserves the right to deny any contract that it does not deem to be in the best interest of the Club, without explanation. While ASTC will make every effort to accommodate court requests it reserves the right to move contract member’s courts to facilitate repairs and improvements.
